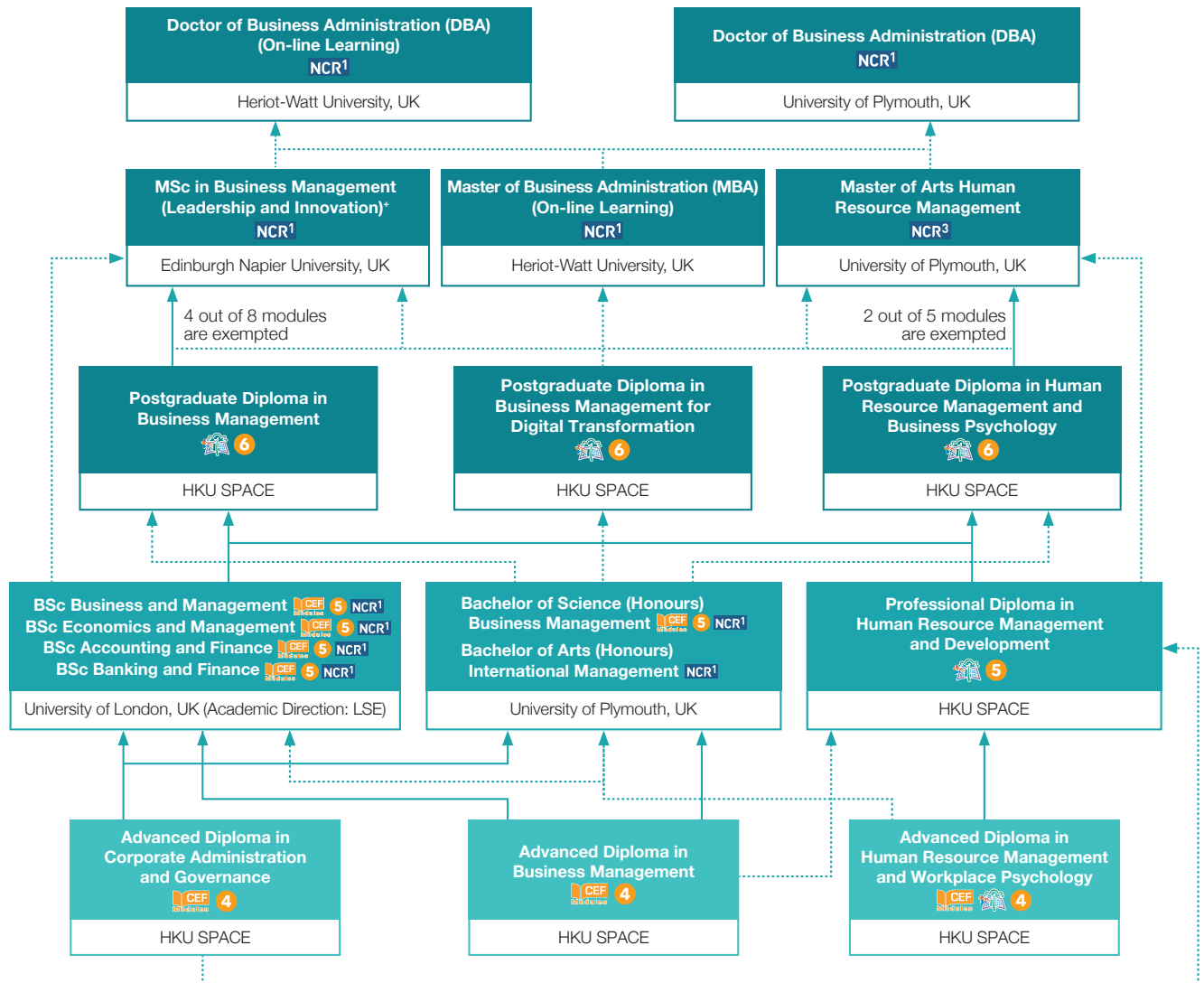

The programme is designed to fit around your working life as a self-study, online programme. There is no fixed start date for this programme, so you can begin at any time. This programme aims to improve your research skills and cultivate bold thinking. The first year of the programme will focus on research methods and skills. Once the student has passed the 3 research models, they will move to focus on writing the doctoral thesis.

The programme is suitable for professionals with basic research skills that prefer to study independently on their own at the research stage and with an appointed supervisor from Heriot-Watt University during the thesis stage.

WHY THIS PROGRAMME?

- Highly flexible – study at your own pace (minimum of 4 years and maximum of 10 years of study).

- 100% distance learning so you can study anytime at anyplace.
- Only 3 research courses before embarking on the DBA thesis, each course to be assessed by a three-hour timed-online assessment.

R Distance learners can commence at any time and study on a stage by stage basis. All candidates are enrolled with Edinburgh Business School (EBS) at the point of entry. To be eligible for registration as a Heriot-Watt student (matriculated), a candidate shall hold all of the following qualifications:

- A master's degree awarded by a recognised institution;
- Five years of relevant working experience.

If the degree or equivalent qualification is from an institution where the language of teaching and assessment is not English, or the degree (taught in English) is over two years, students shall provide evidence of English proficiency, such as:

- a minimum overall IELTS score of 6.5 with no score lower than 6.0 in reading, writing, speaking and listening (or equivalent English proficiency test); or
- a letter from the HR department of the company that you work within, confirming that English is the main language in your workplace.

The programme is studied part-time in a structured manner with a cohort of peers from a range of professional practices. A key emphasis of the programme is the strong teaching and supervisory support from the University of Plymouth. A thesis supervisor will be allocated upon a student's acceptance and will be the mentor to the student throughout their DBA journey. In addition, the research modules in years 1 and 2 are taught modules so students are well-prepared for their thesis development.

- Strong commitment to educational inquiry and critical reflection on practice as a means of professional learning
- Ability to work collaboratively in exploring and developing experience
- Personal statement about the applicants' professional experience and commitment to take up the challenge of a DBA (800 words)
- Research idea to describe the research area applicants hope to investigate for their DBA (1,000 words)
