By studying this programme, you will:

- critically evaluate and apply management accounting and financial management techniques to businesses operating in complex and dynamic environments, incorporating an awareness and appraisal of sustainable development, ethical considerations, and recent technological developments
- identify, collect, analyse and interpret financial and non-financial data from a variety of sources to solve problems and support decision-making

- develop ethical capacity to apply professional scepticism, navigate complex ethical and moral situations, and make informed and ethical decisions
- critically evaluate a range of contemporary theories, models and concepts in accounting and synthesise these to devise optimal investment and financial risk management strategies for businesses
- gain technical accounting and professional skills (e.g. critical thinking, self-efficacy and communication)
- apply critical, analytical and problem-solving skills, including critical analysis and evaluation of data, drawing reasoned conclusions to formulate effective strategies

- engage critically with academic, professional and other literature, to formulate relevant questions, undertake analysis and independent project management to enhance knowledge and drive innovation or change
- apply financial management and management accounting techniques to quantitative and qualitative information for decision-making, risk analysis, planning, control and performance evaluation
- engage in critical self-reflection, ethical awareness, and well-developed interpersonal skills including numeracy, collaborative problem-solving and effective time management.



How you study

This BSc programme is offered fully online and allows you to flexibly fit your studies around your schedule.

You can study part-time or full-time to suit your needs, completing the programme in as little as a year or up to three years.

Each module is run over a 16-week block followed by an online examination, except for the Project module which is run over two teaching sessions and is assessed by written submission.

We anticipate that this programme will be available to study at a Recognised Teaching Centre (subject to centres being approved to deliver the programme), giving you the opportunity to have local, face-to-face support.



Programme structure

The programme comprises three modules – Financial Management, Performance Management, and a research-led Project – designed to equip you with the specialist knowledge and practical skills needed to succeed in finance and accounting.

Financial Management (30 credits)

Gain advanced knowledge of financial management issues within modern corporations. You'll learn to justify and make efficient decisions on financing, investments, valuation, and risk.

Performance Management (30 credits)

Learn how to use various management accounting techniques and evaluate their strengths and limitations. You'll extend your knowledge of crucial areas like budgeting, planning and control, and performance evaluation, gaining the skills you need to contribute meaningfully to organisational strategy.

Project (60 credits)

Delve into specialist interests by identifying an issue, conducting guided in-depth

individual research and effectively communicating your findings. You'll be introduced to a range of research methods and methodologies relevant to the accounting field and contribute to academic and professional practice literature.

Online support

The programme is delivered online and there is no requirement to come to the UK as part of your studies.

Our flexible online programme allows you to work around your own schedule and leads to a globally recognised qualification.

When you register, we will create your Student Portal account. You can then access your University of London email account and other key resources including:

- the Virtual Learning Environment (VLE), which offers online learning support and study materials, access to online academic support and discussion areas to communicate with fellow students
- the Student Guide with helpful information on a range of issues relating to your study experience



- the Online Library with over 100 million ebooks, ejournals, conference proceedings and more. You can also request items not held in the library via the Online Library's Inter-Library Loan service with the British Library
- access to the resources located within Senate House Library
- an employability skills module on how to manage your career in the future, available through the VLE.

Web-supported learning

You can choose the web-supported study option, which provides you with an Online Tutor to support you in your studies. Online tutors will respond to academic queries, monitor and facilitate discussions, and anchor you each week of your studies to help you stay on track.

Assessment

Each module, excluding the Project module, is assessed by an end-of-module online examination. The Project module is assessed by written submission. All assessments and examinations are scheduled online, and you must ensure that your device is kept up to date and complies with University Computer Requirements.

Study materials

All essential resources, activities, videos, discussions and support are provided through the VLE. This allows you to fit your studies around your work commitments. There is no need to purchase additional textbooks.

Students are required to maintain their ACCA subscription during the

programme to access the ACCA Study Hub, a digital study platform available globally with online study content, short quizzes, practice and revision questions and flashcards.

Time commitment

The flexible approach to learning allows students to complete the BSc in a minimum of 12 months (subject to module availability) up to a maximum of three years.

You can study at your own pace, adjusting the intensity to suit your needs.



Entrance requirements and further information

Entry requirements

To be eligible to register, applicants must meet the following requirements:

- Age 17+ by the registration deadline of their enrolment session.
- No outstanding debt or legal flags on their ACCA account.
- Passed or gained exemptions for all of the Applied Knowledge (Business and Technology, Management Accounting, Financial Accounting) and Corporate and Business Law exams.
- Passed, with ACCA, the Financial Reporting, Taxation, and Audit and Assurance exams. Should students have an exemption with ACCA for any of these exams, they will need to forfeit the exemption and

pass the exam with ACCA. The University of London will not allow exemptions for these elements.

- From the start date of the intake applied for, no more than five years have passed since the achievement of their passes for the following exams: Financial Reporting, Taxation, and Audit and Assurance.
- All applicants must satisfy the English language requirements. The proficiency requirements are satisfied through eligibility to register on the programme as detailed above.

Computer specification and internet access

The University of London sets minimum basic computer requirements because your study resources are accessed via the Student Portal. You must be able to download and install software to your Windows or MacOS device to include secure examination browsers for online assessment purposes (if offered on your programme of study). Minimum device requirements are subject to change and older operating systems may become obsolete over time.
